**1. YOUR PRIVACY IS IMPORTANT TO US**

**7. INDIVIDUAL RIGHTS**

<b>Right to Rectification</b>	The right to have personal data rectified if it is inaccurate or out of date.
<b>Right to Erasure</b>	The right to have personal data deleted.
<b>Right to Restrict Processing</b>	The right to limit the way we use or disclose your personal data.
<b>Right to Data Portability</b>	The right to have PI transferred to oneself or to another controller, in a machine-readable electronic format.
<b>Right to Object</b>	The right to request that Emmes stop processing personal data, where processing is intended for direct marketing, or the legal basis is “public task” or “legitimate interest”.
